FISCAL AND BUDGET

1. Adopting Property Tax Relief for victims of natural disasters (Harvey)?

UNDECIDED: I would need to gather more information regarding the short and long term economic impact to our citizens.

2. Revising city ordinances to address conflicts of interest in awarding city contracts?

SUPPORT: We are experiencing costly consequences resulting from methodology of awarding city contracts. The complete lack of accountability is costing the city taxpayers millions of dollars, resulting in reduction and loss of basic city services. The way city contracts are currently awarded are a complete mockery to the competitive bidding process, contractors are not held accountable, and are not awarded based on performance. This has cost our taxpayers not only in the way of loss of city services, but also in continuous loss of quality of life, our homes, our vehicles, and loss of life in some instances.

3. Policy change directing that all city funds received through drainage be spent on flooding remediation and drainage enhancement projects

SUPPORT: Rain tax fees have been used to pay down other debt instead of being used for the purpose it was intended. This referendum passed and was voted upon for the specific purpose of flood mitigation projects, to use funds for other purposes is deceitful and has resulted in continuous flooding.

SUPPORT

GROWTH MANAGEMENT

5. Adopting commercial and /or residential zoning ordinances or other growth management restrictions

OPPOSE: We must exhaust all other possibilities and include community participation prior to deciding the fate of peoples homes and business and making decisions that will potentially displace families and businesses.

COMMUNTIY PROTECTION

8. Enforcing maximum legal restrictions of all Sexually Oriented Businesses equally?

SUPPORT: Sexually oriented business often serve as a conduit to human trafficking, drugs, violence, and other criminal behavior. I support any and all enforcement of legal restrictions to ensure the safety of our communities.

I would call for strategic partnerships which include churches and CBO's participation to determine the root causes, and best to address the problem.

SUPPORT: I believe that campaign finance reform is necessary and should be applied to all individuals who contribute to campaigns including those who operate Sexually Oriented Businesses.

departments to determine how to streamline operations and reallocate resources in order to allocate funding and resources to both our Police Department to increase cadet recruitment efforts, increase the number of cadet classes, as well ensuring we have adequate resources to keep our officers safe.
