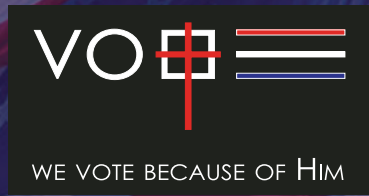

CANDIDATE SURVEY QUESTIONS:

1. Policy change directing that all city funds received through the drainage fee be spent on flooding remediation and drainage enhancement projects.
2. Enforcing maximum legal restrictions on all Sexually Oriented Businesses equally
3. Prohibit abortion except to save the life of the mother; some support rape and incest exceptions also.
4. Prohibiting adult sexual content and performers in Houston Public Library system programs and materials accessible to children.
5. A city ordinance creating discrimination protections for sexual orientation, gender identity or other sexual behavior.
